Mr. Aboughazala has worked under my supervision as research assistant (HiWi) at the German Research Center for Artificial Intelligence (DFKI) between 2022 and 2023.

Mr. Aboughazala helped me in the development of an Augmented Reality application for the visualization of a virtual interpreter for Sign Language. He has developed the research prototype for iPhone and for Microsoft Hololen 2 devices, using the Unity 3D game editor, and integrating other libraries such as the MRTK toolkit. In addition to the development of the stand-alone app, Mr. Aboughazala worked also on the integration of such app with a server using Blender as backend for the dynamic generation of animations.

Mr. Aboughazala proved to be able to cooperate with other members of the team in the analysis of the problems and in the conception of innovative solutions. Remarkably, he has been able to autonomously deal with implementation details and to proactively move towards new solutions even before an explicit request was made.

In general, I greatly appreciated his responsible attitude and the strong dedication in accomplishing his tasks in time. He has been a valuable member in the development team.
